- Full Bond Membership – In year one, you pay the entire \$250 bond fee in full, plus the annual dues. In future years, you pay only the annual dues assessed for that year.
- Optional Bond Membership – Full bond is paid over three years in \$100 installments which include a \$50 service charge.

Each year you will also pay the annual dues. If you choose this option, please review the details on the Certificate of Optional Bond Membership detailed below; complete, sign, and return it with your application.

The fees for new members are listed on the New Member Invoice. Both membership types require a \$50 application fee. Please complete the Member Application and the New Member Invoice and send both along with your check as instructed on the New Member Invoice.

Certificate Of Optional Bond Membership

**** complete ONLY if choosing the Optional Bond Membership payment****

This agreement is made between

("Optional Bond Member") and Whitpain Greens Swim Club ("WGSC") on this date, _____ with the following provisions:

- Optional Bond Member agrees to pay bond fees plus the assessed annual dues over a period of three (3) years before full bond membership privileges will be granted by WGSC
- Non-payment of dues by Optional Bond Member for two (2) years will automatically forfeit monies paid to WGSC and will terminate the optional bond membership
- Bond fee must be paid in full for any monies to be refunded. If the Optional Member chooses to terminate membership prior to achieving full bond membership status, no monies are refunded and membership to WGSC is terminated
- WGSC agrees to afford all privileges of WGSC to the Optional Bond Member, except those share ownership and voting rights, while this agreement is in effect
- WGSC agrees to issue a stock certificate to the Optional Bond Member once the bond fees are satisfied
- Optional Bond Member has the privilege of accelerating payment of bond fee, and, upon satisfaction of the fee, WGSC will issue a stock certificate
- Optional Bond Member agrees that in the event the above conditions are not met, all monies are forfeited to WGSC. Money paid is NOT refundable prior to full purchase of stock certificate.
